

### Internship Job Description: Air Quality Research Intern

- Assist in the development of new concepts and projects based on research outcomes.
- Collaborate with the team to identify potential strategies and interventions to improve indoor air quality in Hong Kong.

- Current enrolment in a college or university program, preferably pursuing a degree in environmental science, public health, policy studies, or a related discipline.
- Demonstrated interest in environmental health, policy analysis, and sustainability.
- Strong research skills with the ability to conduct thorough desktop research and analyze complex information.
- Excellent written and verbal communication skills.
- Ability to work independently and collaboratively in a dynamic team environment.
- Knowledge of Hong Kong's environmental policies and initiatives is advantageous but not required.
